RECONSTITUTION OF ANTI-RAGGING COMMITTEE

1. As approved by the competent authority, sanction is hereby accorded for re-constitution of **Anti-Ragging Committee of the Institute** comprising of the following members for a term of two-year w.e.f. the date of the Office Order: -
 - a) Dr. Neelarnab Dutta, Senior Faculty: In-Charge
 - b) Sudev Kumar Mandal, Associate Senior Faculty: Member
 - c) Bhaktadas Bora, Faculty: Member
 - d) K. Harish Singh, Faculty: Member
 - e) Bhaswatee Likhok, Faculty: Member-Secretary
2. The objectives of the Committee shall be as follows:
 - a) To prevent the menace of ragging and foster healthy interpersonal relations among students in the campus of NID, Assam
 - b) To aware the students of dehumanizing effect of ragging inherent in its perversity.
 - c) To keep a continuous watch and vigil over ragging so as to prevent its occurrence and recurrence.
 - d) To promptly and stringently deal with the incidents of ragging brought to notice to the Anti Ragging Committee.
3. The responsibilities of the Committee shall be as follows:
 - a) The Anti-Ragging Committee shall develop strategies and action plans to prevent and address ragging.
 - b) The Anti-Ragging Committee shall conduct awareness programs on campus to educate students about the dangers of ragging.
 - c) The Anti-Ragging Committee shall monitor campus and hostel areas to prevent ragging incidents.
 - d) The Anti-Ragging Committee shall investigate any reported ragging incidents and take appropriate action.
 - e) The Anti-Ragging Committee shall provide guidance to students on how to report ragging incidents and seek help.
 - f) The Anti-Ragging Committee shall work in coordination with the Academics Office and Hostel Administration.
 - g) The Anti-Ragging Committee shall hold meetings to discuss issues, review progress, and make decisions.
 - h) The Anti-Ragging Committee shall keep minutes of all meetings, including decisions and recommendations.
 - i) The Anti-Ragging Committee shall submit reports to the Head of the Institution as and when directed.
4. The term of the members of the Committee shall be two years from the date of the Office Order.
